This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

#### Section 4 - First Aid Measures

## **General Information:**

# **Section 6 - Accidental Release Measures**

**Accidental release:** Avoid spashes or spills. Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses.
